## Competition Rules:

- This is a *fun* dog show and winners are judged and picked accordingly. **The judge's decision is always final.**
- The organizers have the right to refuse any dog or handler entry to the show. The dog's behavior is the responsibility of the owner, and control of animals must be maintained at all times. Participants/dogs will be required to leave if a dog shows any signs of aggression toward people or other animals.
- No dogs may attend if they are in season/in heat.
- Owners must bring a full set of vaccinations.
- Dogs must have a current rabies vaccination and be wearing a rabies tag.
- Dogs must be kept on a leash no longer than six feet in length at all times (**No retractable leashes allowed**).
- Dog owners/handlers must clean up after their dogs and dispose of pet waste in designated receptacles.
- The safety and well-being of all animals at the show is the responsibility of the owner.
- Rotary Club of Southeast Missouri Service, its volunteers, Uptown Jackson Revitalization Organization, or the City of Jackson cannot take any responsibility for any loss or damage caused to people, animals, or property whilst on the showground.
- The committee reserves the right to alter or amend the schedule of events as necessary.
- All class winners automatically qualify for the best in show competition.
- The event is held in conjunction with the Jackson In Bloom festivities and will follow decisions made by the Jackson In Bloom Committee in the event of adverse weather. Rain date for the event will be May 6. Since this is a charity event, no refunds will be issued.
- If you have entered your dogs into the dog show, it is your responsibility to listen for announcements of the class times and start times.

**Waiver and Release:** I, the Participant, do release and forever discharge, indemnify, and hold harmless the Organizers and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my participation in the Competition.

**Assumption of Risk:** I understand, appreciate, and acknowledge that participation in the Competition may include activities that may be hazardous to me and others, including but not limited to being jumped on, scratched, bitten, chased, knocked over, or tripped as the Competition invites a large number of dogs to participate and any event involving animals includes the potential risk of property damage or injuries that could be caused by said animals. I hereby expressly assume the risk of injury or harm from Competition participation and Release the Organizers from all liability for injury, illness, death, property damage, or other loss resulting directly or indirectly from my participation in the Competition.

**Other:** I acknowledge that this Release shall be governed by and interpreted in accordance with the laws of the State of Missouri. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

This waiver shall remain valid and may not be unilaterally rescinded by the participant. This form is to be signed by participant or by a parent or legally responsible guardian if participant is less than 18 years of age to be signed.

I give permission for Organizers to use pictures and filming taken of me, my pet(s), or my child(ren) (as applicable) during the Competition to be used by Organizers for promotional purposes in the future. I also give permission for my or my child(ren)'s name and image to be used to announce the winners of this competition in the local newspaper, radio, and/or on social media.
